

# Newport and Harwood to Be Linked by Emergency-Access Road

The CVE Reporter has learned that plans are underway for a new connector road inside Century Village East that will link the Newport and Harwood areas

— a project designed exclusively for emergency-vehicle access and improved safety.

The connector will run parallel to Southwest 10th Street, bridging the existing parking lots of the two sections, which are currently separated by water. When completed, the new roadway will allow fire engines and other emergency vehicles to travel between Newport and Harwood without having to travel back out to West Drive and Century Boulevard or reverse from the dead ends at both locations. According to CVE Master

Management, the new road will be built in coordination with the Florida Department of Transportation's upcom-

# Combined Coupons Push Past \$300

Residents of Century Village East will see increases to both their recreation and CVE Master Management coupons beginning January 1, 2026, as each governing organization approved new budgets citing inflation and rising operating costs as the primary reasons. When added together, the two fees are now over \$300 for the first time.

CenClub, which oversees the community's recreation facilities, announced that its monthly coupon will rise ten dollars to \$120 per month. During the board's meet-

ing, members described the increase as necessary to offset what they called a "steady spiral" of inflationary expenses. In announcing the adjustment, CenClub claimed that

its coupon "is still the lowest of the three paid by residents — by far" when compared to the monthly assessments

# Decades of Coverage, and We Still Notice the **Little Things**

resh white lines now  $\mathbf{f}$  brighten the walkway along Century Boulevard near the clubhouse, thanks to recent re-striping work completed by CVE Master Management. It's the kind of small improvement that many residents might walk past without a second thought but it's exactly the kind of detail the CVE Reporter notices. After all, we've been covering this community for

more than three decades, and we've learned that it's the little things that often make the biggest difference.

From newly painted curbs to upgraded sidewalks and walkways, these quiet improvements reflect the ongoing care and attention that keep Century Village East looking its best. The re-striping project is a simple touch, but together, small efforts like these add up to a cleaner,

safer, and more beautiful Village—one that continues to shine year after year.

ing upgrades to Southwest 10th Street, scheduled to begin within the next year or two. By aligning the timing of both projects, CVE Master Management can reduce costs and minimize disruption to nearby residents.

"The purpose of this connector is purely safety," a **CVE Master Management** spokesperson said. "It's about giving first responders better access to both communities

and ensuring large emergency vehicles have the space to maneuver safely."

Access to the connector road will be restricted to emergency vehicles only. A gate will be installed at each end, and entry will be controlled by a transponder system available exclusively to authorized first responders. Regular resident or visitor traffic will not be permitted.

Once complete, the project will provide an important new safety connection be-

tween two of the Village's largest sections — part of CVE Master Management's ongoing efforts to modernize infrastructure and enhance emergency response throughout the Village.

charged by CVE Master Management and the individual associations.

CenClub also pointed to what it called the broad benefits that its investment in amenities brings to the community. "The amenities that CenClub builds, main-

tains, and modernizes in this community contribute in a significant way to the continuing stabilization and growth in the village."

CVE Master Management, which handles the community's infrastructure, transportation, security, and utilities, also approved an increase for 2026. The CVE Master Management coupon will increase by \$13 to \$185. The organization says the adjustment was unavoidable due to surging costs for essential services that "are completely outside"

The management company explained that nearly every dollar collected goes directly to paying for vital operations

 including cable television, water, sewer, trash, and electricity — all of which have experienced sharp price hikes.

Both CenClub and CVE Master Management expressed appreciation for residents' understanding as they navigate higher costs while working to maintain the comfort and safety, and

uphold property values.

The coupons for CenClub and CVE Master Management represent two of the three significant monthly costs paid by residents. The third is generated by individual buildings. The amount of monthly building fees varies from building to building.

# Major Tree Collapse Underscores Ongoing Risk from Untrimmed Trees

On October 3rd, a large tree suddenly crashed across the roadway near the intersection of Grantham and Century Boulevard. The incident prompted a prompt response from the Broward Sheriff's Office and on-site security personnel, who secured the area and facilitated removal. Fortunately, no one was injured.

While the event ended

without physical harm, it serves as a stark reminder that even a single unmaintained tree can pose a significant hazard — particularly in communal living environments where trees are near vehicles, pedestrians, and infrastructures. Tree failures in urban settings are a documented concern: studies note that structural defects in roots, stems or branches can

lead to sudden collapses, and in urban contexts these incidents can affect public safety, infrastructure and property.

While CVE Master Management is responsible for tree maintenance along the Boulevard, each association is responsible for maintaining trees on their property. Mature trees near roadways or common areas demand periodic inspection and



trimming to reduce risk of failure — particularly in a region like South Florida that endures high winds, heavy rainfall and tropical storms.

Village officials say the October 3rd event should prompt the buildings' leadership to review their current tree-maintenance practices

and ensure that inspections, pruning schedules and accountability mechanisms are in place. Whether it's addressing overgrown canopies, removing dead or dying limbs, or assessing trees showing signs of structural decay — the cost of neglect can be far greater than annual maintenance.

# Deadline to File for Elections

Century Village East residents have until the end of the first week in November to submit their names to run for one of several open leadership positions that help shape the future of the community. The deadline to file candidate applications is Thursday, November 6, at 3:00 p.m.

Applications are now being accepted for open seats on

three major governing boards: the CenClub Board of Directors, the CVE Master Management Board of Directors, and COOCVE. Elections will take place in early January.

Both the CenClub and CVE Master Management boards each have three open seats, with directors serving three-year terms. All seven officer positions on COOCVE

are also up for election, with terms of either one or two years, depending on the role.

Any unit owner in the Village is eligible to run. Candidates must complete an application form and include brief biographical information. Forms are available at the CVE Master Management office, the COOCVE office, and the clubhouse, and can

also be downloaded from the COOCVE website. Completed applications may be submitted in person or emailed to CVEElections@COOCVE.com, but all submissions must be received before the 3:00 p.m. deadline.

Serving on one of the Village's governing boards is an opportunity to help guide key decisions that affect more than 16,000 residents. Together, the CenClub and CVE Master Management boards oversee roughly \$30 million in funding, directing policies, maintenance, amenities, events, and long-term planning for the community.

# CVE Master Management Relaunches "9-1-1 Is #1" Campaign

With seasonal residents returning to Century Village East, CVE Master Management is relaunching its community safety education campaign, "9-1-1 Is #1," reminding everyone that in an emergency, the first call should always be to 911 — not Village Security.

The campaign, which will run through the month of November, emphasizes the proper role of Village Security within the community. Security officers are responsible for gate access control, perimeter patrols, and monitoring the exterior walls and entrances of the Village. Their duties are

limited to observing and reporting incidents to local first responders.

"Security officers are not first responders," a CVE Master Management spokesperson explained. "Their role is to maintain access control and report incidents to the appropriate authorities. In an emergency, time matters —

and residents must always call 911 first."

The relaunch of 9-1-1 Is #1 aims to refresh residents' awareness after the summer season and to ensure that everyone — full-time and seasonal residents alike — understands the difference between security services and emergency response.

The campaign will appear in the CVE Master Management INSIDER newsletter, on the website, on the village television channels and on digital signage around the Village throughout November, reinforcing one simple message: In an emergency, 9-1-1 should always be your first call.

# Public Forums on Future of City Police

Residents of Century
Village East will soon
have an opportunity to weigh
in on one of the most significant local issues in decades
— the possible creation of a
new Deerfield Beach Police
Department.

The City of Deerfield Beach has announced a series of public forums in November to gather community feedback on the future of public safety services. The discussions come as the city begins a two-year transition away from its long-standing contract with the Broward Sheriff's Office (BSO), which has provided police and fire-rescue services to the city for more than 35 years.

The closest meeting to Century Village East will be November 13th at the West Deerfield Community Center at 580 Powerline Road. There are two sessions. The first is at 11:00am and the second is at 7:00pm. Other meeting dates are listed on the city's website. Each meeting will include both morning and evening sessions to allow broad public participation.

According to city officials, the meetings are designed to

give residents a direct voice as Deerfield Beach studies whether to establish its own municipal police department, continue contracting with outside agencies, or pursue another model of service.

The city formally entered a 24-month transition period on October 1, 2025, during which it will explore costs, staffing, and operational structures for

a potential Deerfield Beach Police Department. Officials have emphasized that the goal is to strengthen public safety while ensuring transparency and fiscal responsibility.

City leaders say the upcoming meetings are not about politics but about building a sustainable, locally accountable model of public safety. "This important conversation is not about power or personalities," the city announcement stated. "It's about protecting the people of Deerfield Beach and ensuring that every tax dollar is spent wisely and effectively."

As the process moves forward, The CVE Reporter will continue to follow developments closely to keep Village residents informed about how these decisions may affect local public safety services.

# Six IDs Taken in One Weekend as Security Tightens Rules

Security officers in Century Village East are reminding residents to follow the rules when it comes to using their resident identification cards. According to village security, an average of 35 to 45 IDs are confiscated at the gates every month because they are being misused.

The most common reason for confiscation occurs when residents allow someone else to use their ID to enter the community. In some cases, it's a family member, caregiver, or renter. But regardless of the reason, if an ID is used by anyone other than the resident whose

name appears on it, security officers are required to confiscate it.

In one weekend alone, six IDs were taken by gate officers after being used improperly. Once an ID is confiscated, it must be recovered the following day at the clubhouse. Security officials stress that the rules are clear — and printed directly on the ID cards — stating that the cards remain the property of CenClub and may be confiscated at any time if misused.

"Security is a team effort," said Christopher Kelley, head of security in the Village.

"Our guards can only do so much to maintain the security of our village. It requires the cooperation of the residents to also follow the rules that we have in order to make sure that we have the most secure community possible."

Security officers say that while most residents follow the rules, a small number of violations can create unnecessary challenges for the team working to protect the gates and ensure that access is properly controlled. Following ID procedures, they say, is a simple but essential part of keeping Century Village East safe for everyone.

# **No More Day of Rest** for Route 48

n a move aimed at ex-**⊥**panding public transit access, Broward County Transit (BCT) has begun offering Sunday service for its Route 48. The change means riders who rely on the 48 bus between the village and the beach and other stops along its weekday and Saturday route can now board on Sundays as well.

Route 48 previously operated Monday through Saturday with no Sunday trips. With the new Sunday service, village residents gain direct Sunday ac-

cess to the beach via the county system — eliminating the need for the village's supplemental Sunday beach bus.

As part of the transition, the village's dedicated Sunday beach shuttle has been discontinued. In a statement, village officials said the change will allow them to redirect the vehicle and staffing resources from the discontinued beach shuttle to focus instead on other transportation needs within the village.

Transit planners say the



expanded Sunday service of Route 48 aligns with broader county goals of increasing mobility and connectivity across Broward County. BCT notes that its fixed-route service "is the most accessible,

affordable and economical way to travel throughout Broward County"

Residents who use the beach shuttle on Sundays are urged to familiarize themselves with the new schedule

and stop locations for Route 48. Officials recommend arriving early at stops while the new service launches, and to stay tuned for any updates as the system adjusts to the expanded schedule.

well-being of CVE residents remain my highest priority; I have been a full-time resident here since 2001 and know how much this matters.

#### Why We're Relaunching "9-1-1 is #1"

Every year, as residents return to Century Village East for the winter season, we take time to revisit some of the most important safety reminders that help keep our community secure and well-informed. One of those reminders is at the heart of our campaign, "9-1-1 Is #1."

It's essential for everyone to understand the specific role

that Village Security plays — and, just as importantly, what it does not. Our security officers provide three vital functions: they control access at the gates, patrol the perimeter of the Village, and observe and report any incidents to the proper authorities. Their mission is to ensure that only authorized individuals enter the property and to maintain the integrity of our perimeter.

However, they are not first responders. They do not pro-



vide medical assistance, fire-fighting, or law-enforcement response. In any emergency — whether it's a medical situation, a fire, or a safety threat — your very first call must always be to 911.

The men and women who staff our gates and patrol our property play a critical role in the overall safety of Century Village East, but they rely on your cooperation to make the system work as intended. Knowing who to call — and

when — helps everyone.

By relaunching "9-1-1 Is #1" this November, we're reaffirming our shared responsibility for safety. The faster 911 is called, the faster trained emergency professionals can respond. That simple action can make all the difference.

Let's work together to keep Century Village East safe, informed, and prepared.


#### HOUSE BILL 913 -MORE HIGHLIGHTS

- Association election ballots may be received by e-mail. Boards must designate a separate e-mail address, such as <u>VentnorN@gmail.com</u> to receive the completed ballots and an "e-mail administrator" who will review all inbox, spam and junk folders to ensure all ballots are properly counted. To be valid, ballots should be scanned and attached to the e-mail.
- Buildings with more than 25 units must have a website and official records are required to be posted on the website within 30 days. (See coocve.com for a list of required records to post).
- The deadline for making Annual Financial Reports available to owners is extended from 90 to 180 days after the end of the fiscal year. They don't have to be sent to all owners, only the notice that they are available upon request. If requested, they must be delivered within 5 days, and there must be an affidavit to verify that this was done.

#### DID YOU KNOW?

**Insurance:** Florida Law requires associations to insure the building for it's replacement value.

An independent insurance appraisal on the replacement cost must be done at least every 3 years. fs 718.111(11)(a)

**Surge Protectors:** Consider putting a surge protector on your elevator's main electric panel to avoid damage during an electrical surge or outage.



#### TREE ROOTS INTRUDING?

Buildings are finding tree roots intruding into plumbing, toilets, bathtubs and now lanais. Consider hiring a licensed company to cut a trench between the trees and your building to block the roots from further intrusion. It is a great alternative to cutting down a beloved tree.

In a sentence, their position is that each Association is 100% responsible for all iguanas on its property, no exception.

In the September Edition a rebuttal was published outlining in detail the damage of iguanas. The property damage, building damage, landscape damage, and details of the life of iguanas. Among the facts: Iguana life span is between 10 to 15 years and female iguanas lay between 20 to 70 eggs annually.

Much discussion occurred between buildings and in the Presidents Forums. As is always the case, never-ending discussion, but no practical movement.

In October Edition, some solutions were reported that summed up the meetings and discussions. To date, we are in a stalemate. CVE surrenders, iguana's win.

Perhaps we need to circulate petitions, so Master Management knows a large percentage of owners consider this an important village wide issue. Perhaps we need to seat new

Board Members on the Master Management Board of Directors who will take this issue seriously. There are 3 positions currently open. If interested, November 6th at 3 PM, is the deadline to submit your name.

Each year, 253 condominium associations in Century Village East manage more than thirty-five million dollars of residents' money, covering insurance, maintenance, landscaping, and reserves that protect every building's longterm health. Every association operates independently, electing its own board and setting its own budget.

In theory, that allows each building to make decisions suited to its needs. In practice, it produces 253 separate systems repeating the same work, the same mistakes, and the same questions about what the law requires. Each board is responsible for legal compliance, budgets, reserves, insurance, contracts, and safety rules. They rely heavily on property management companies whose quality and consistency vary widely.

The current system de-

pends almost entirely on the knowledge and commitment of volunteers. State-mandated training for board members is limited to a four-hour course and a signed statement claiming they have read their documents. Many skip even that step. When experienced members step down, their knowledge leaves with them, and new volunteers start from zero. Among CVE's twelve hundred directors, experience, knowledge, and commitment vary widely, producing uneven results from one building to the next.

Meanwhile, the workload never stops. Every year brings new laws, inspection rules, insurance mandates, and financial reporting requirements. Each board must read, interpret, and apply them. COOCVE offers guidance, tools, and best practices, but cannot enforce them. Some boards follow the advice, others ignore it. Without shared standards or even consistent voluntary compliance, each board ends up reinventing the wheel, and the duplication of effort is staggering.

The combined budgets of Master Management and Cen-Club are smaller than what all the associations manage together. Yet both organizations employ trained profes-

sionals who are monitored, evaluated, and held accountable. They set standards, measure performance, and act when results fall short. Most associations would never accept the same level of service from Master Management or CenClub that they routinely tolerate from their property management companies.

The effects reach far beyond money. The quality of life in CVE varies dramatically from one building to another, depending on how engaged and competent each board is. Board effectiveness directly influences maintenance, safety, communication, and overall livability. In some buildings, life runs smoothly. In others, frustration and neglect have become the norm.

A system built on volunteer effort alone cannot sustain the size and complexity of what CVE has become. The structure depends more on luck than design. When capable people serve, things run well. When they do not, small problems quietly grow until they become crises.

There are better ways. A stronger shared management framework, professional oversight, and common reporting standards would not take control away from associations. They would protect owners by

ensuring basic competence and accountability across the Village.

Even small steps can make a big difference. Shared vendor lists, standardized budget templates, reserve reports, and maintenance schedules could reduce duplication, improve compliance, and lighten the board's load. Centralized training and communication tools would raise standards, lower costs, and enhance quality of life. Practical steps to achieve these goals will be outlined in a future article.

Oversight of associations in CVE is not weak, it is nonexistent. For a community managing thirty-five million dollars in collective funds, that is unacceptable. The system is failing not because people are careless, but because too few have the tools, training, and structure to make it work. Real change will begin only when owners ask hard questions, demand transparency, and insist that the governance structure evolve. Progress depends on voluntary cooperation and compliance among all 253 associations, because no existing organization has the authority to do it for them.

# Tips for Traveling

## Be Practical When Packing

Pack light. For a person traveling with at least some limitation, aim to pack everything necessary in a roll-aboard suitcase plus a medium size over-the-shoulder carry-on. Do not check the roll-aboard as luggage, as in-cabin flight staff will gladly stash it in the overhead rack. Such will save a lot of time at the final destination airport.

All prescription and overthe-counter medications should be placed in a one quart zip lock freezer bag, including also copies of any prescriptions and/or physician statements in the hand carry bag. Do not place the pill combinations separately into a separate plastic box as "the next combined dosage." Such will never get through security. Enclose also any medical appliances such as extra braces or first-aid needs.

If toting gifts to relatives, do not wrap them. Place the items in the roll-aboard luggage.

# Think about Safety, Security and Comfort

There are thieves
everywhere and,
particularly, in high-traffic
travel centers. Don't give the
scalawags any opportunity to
steal from you.

Women should not carry a purse but, instead, a money belt worn under a blouse or a neat Passage Wallet hidden under their coat by a neck cord. Men should not carry a wallet in his back pocket but, instead, the same Passage Wallet from the neck cord or as a hidden wallet tucked into his pants and secured by a cord to his belt.

If traveling alone, always keep your carry-on between your feet when standing, or with the shoulder strap looped around the leg of a chair when seated.

For comfort, consider the purchase of a travel pillow, a c-shaped balloon that supports the neck and head when resting aboard transportation.






#### **Feeding Wildlife Causes Problems**

resent: Rita Pickar, Stanley Spitzer, Jay Baimel, Michael Rackman, Susan Dove, Arnold Klein Via Zoom: Sheila Pascar. Mike Burdman, the executive director of CenClub, and Norma Taylor with Bay Management were also present.

#### **Minutes:**

Stanley Spitzer moved, and Jay Baimel seconded the motion to waive the reading and approve the June minutes as posted on the CenClub website and printed in the Reporter. The Motion carried unanimously.

#### **President's Report:**

The Clubhouse Tiki Hut at the Pool is completed, and the Board is proud of the final result.

Board Member Rita said there will be a \$10 a month increase to the CenClub monthly coupon beginning January 2026.

Get togethers at pools need to be reserved and glass cannot be at the pool.

Elections are coming up for the CenClub board and  $3\,$ spots are available. COOCVE and master management also, forms available at Staff Office and master management.

November meeting will be held on Monday the 10th, due to the Holiday on Tuesday, November 11th.

## **Correspondence:**

Mike read a letter submitted by Beverly of Tilford B regarding the reservation of LeClub and shared a response.

CenClub has a policy regarding events that may involve soliciting residents. In the past, there have been instances where residents organizing events received compensation or other benefits from attorneys, healthcare professionals, or vendors—some of whom may not have had the residents' best interests in mind and instead sought personal gain.

Due to limited staffing, CenClub cannot thoroughly vet every external vendor or healthcare provider brought into the community. For this reason, CenClub organizes and oversees certain events, such as those involving the Bloodmobile, Hear USA, Homestead programs, Medicare representatives, and the local Commissioner. These events feature vetted professionals to ensure residents receive trustworthy and nonpredatory information.

Residents are welcome to visit the staff office anytime

to discuss concerns. Mike emphasized that CenClub policies and rules are established by the Board, not by staff. Residents with questions or concerns about specific regulations are encouraged to visit Mike in his office or contact him directly by phone.

NOVEMBER 2025

#### **Treasurer's Report:** Jay Baimel

Jay reported that at the end of May 2025 the operating account ended with \$217,526. During June, July, and August, CenClub received \$2,863,112, dispersed \$3,228,911, and transferred \$373,109 to the reserve accounts. At the end of August, the operating account balance was \$224,836, and petty cash was \$5,619. At the end of August, the total operating cash was \$230,455. At the end of August, CenClub had a reserve cash balance of \$2,369,741. As of August 31, 2025, CenClub Recreation Management has \$2,600,196 in total cash. The reserve account at the end of May 2025 was \$2,700,094, and CenClub earned \$12,756 in interest income during June, July, and August. There were net transfers from the reserve to the operating account of \$373,109; therefore, at the end of August 31, 2025, the reserve balance was \$2,369,741. The month end balance in the sweep reserve account consists of deposits below \$250,000, in 13 different banks in order to ensure maximum insurance protection under the FDIC guidelines.

During the eleven months from October 2024, the beginning of the current fiscal year, through August 2025, Cen-Club dispersed \$3,723,000 for budgeted capital projects for 2024/2025.

June through August 2025 expenditures were \$231,000 for the Ashby pool bathrooms, \$135,000 for the bathhouse and amphitheater projects, \$118,000 for the completion of the clubhouse pool, \$103,000 on account to paint the theater ceiling, \$64,000 to roof Lyndhurst South and Upminster pools, and \$13,000 for lighting improvements in the theater, for a total of \$664,000.

Interest income for the eleven months ended August 31, 2025, amounted to more than \$59,000. The average interest rate earned during the summer of 2025 on reserve balances remains at 1.93%. For August 31, 2025, net recreation receivables were \$110,858, down from \$115,223, a decrease of \$4,365. The total assets of CenClub Recreation Management as of August 31, 2025, were \$11,206,944, up from \$10,344,388. Liabilities were \$526,225, up from \$395,411. As a result, CenClub members' equity was \$10,680,719 up from 9,948,977.

Six years ago, CenClub Recreation Management adopted a fiscal year to run from October 1 to September 30 in order to mirror its activities year. Our outside CPA firm will begin their audit for the year end September 30, 2025, in late October. We will expect a completed audit report sometime around the end of this year. In making the budget conclusions, the elected voluntary CenClub board accumulated relevant data, discussed it, analyzed it, and then completed our fiduciary responsibility by formulating a thoughtful and comprehensive plan for the benefit of the entire community. Underlying this process was the understanding that the amenities that CenClub builds, maintains, and modernizes in this community contribute in a significant way to the continuing stabilization and growth in property values for our owners at CVE. As stated last year, we relied upon an updated capital needs assessment and replacement reserve analysis prepared by objective and professional consultants to recalibrate our original 20year capital spending needs. The board has conservatively incorporated various provisions into the calculations for 2026 and for the longer term beyond next year. The foremost mission is to evaluate all future spendings to ensure the highest quality of recreation facilities in order to protect and enrich our community property values. The CenClub board and CenClub employees are proud both professionally and personally of the amenity improvements they have planned and executed for the community during the past several years. The modernized Clubhouse pool is uniquely exceptional in giving users the everyday feel of a resort environment.

As Rita mentioned for the following budget year, the board has voted to increase the coupon effective of January 1, 2026, to a uniform rate of \$120 per month for all owners due to a steady spiral

of inflationary, operating, and capital costs. Despite this increase, the CenClub board remains committed to maintaining your CenClub dues as the lowest of the 3 monthly payments. The operating side of the budget is comparable to the previous year excluding the scheduled projects and reserves. The operating expenses are largely uncontrollable and fixed, amounting to \$9,897,00, 3% higher than the prior year, which resembles the U.S. inflation rate. Jay presented a pie chart on the screen, which will be available in the staff office and online. Under expenses, there are scheduled projects and reserves, \$2,963,301, including significant expenditures to modernize, maintain, and improve recreational facilities. The total is approximately the same as in the three previous years of capital spending. Jay thanked the Board, Mike, and Norma for constructing and validating this budget. Rita thanked Jay for his report.

#### **Executive Director Report:** Mike Burdman, Executive Director

## **Projects underway:**

We are saddened this summer of the passing of a couple of dear friends of CenClub, and champions within this community. Mitzi Rice, our line dance instructor, brought joy, energy, and community to the dance floor here in CVE for over 20 years. Her warmth and passion touched everyone she taught, making each class a celebration of movement and friendship. Rhonda Pitone, a regular here in the Clubhouse, has had a passion for improving the lifestyle for all within the village. She has been an encouraging and beloved member of our community for over 25 years.

As Rita said there will be a \$10 a month increase to the CenClub monthly coupon beginning January 2026. This increase is due to the consistent rising costs of the operation of the CenClub facilities as well as continuing to keep or reserve accounts in line with our most recent capital needs study. Should you have any questions you can come and see me at the administration office any time.

Credit cards will not longer be an option for Auto-Pay for the recreation fees. If you would like to pay with a credit card, you may pay in the Payment and I.D. Office. Credit card payments will be

charged a 3% processing fee. A video of the recent summer projects was shown.

Recreation updates:

- Since our last public meeting in June our Main Chilled water AC units that service the largest parts of our Clubhouse, the Party Room and the GPA wing, have been replaced. Cranes were used to remove and install the new, custom made units and I want to thank all involved in the very complicated project. The units are online and working great!
- Construction has been completed on one of our newest CenClub amenities. A new Tiki Hut was installed on our Clubhouse Pool Deck. This new feature not only provides shade but also offers a new tropical feel to our resort style pool.
- Construction is ongoing on our New CenClub Basketball court. The Court is located on the back side of the Racquetball / Sports wall and will make an amazing new addition to our sports complex area.
- Renovations are complete at the Ashy Pool Bathhouse. The new look compliments the newly redone pool and deck area and matches the new look at several of the other pools.
- Updates are currently underway to the Party room Sound and light system and will be completed in the coming week. Stay tuned for additional pool-related updates, including Sunday schedule information, which will be shared via email.

## **Upcoming projects:**

- Towards the end of this month, the theater will be closed for renovations, repairs and painting. The project should take no longer than 5 weeks and be completed long before our show season starts.

#### Maintenance and Pools

Through the months of June, July and August, 589 Work orders were completed by our maintenance team and 198 work orders were completed by our pool team. All lights on the property have been surveyed and ordered or replaced as needed. During the summer months all pools have been treated for phosphates. Main Pool Pumps were replaced at Berkshire and VentnorThe Clubhouse pool underwent 3 months Service and is now prepped for annually scheduled maintenance. A safety inspection has been completed on all swimming pools and no issues were noted on equipment or facilities. Security is actively monitoring the pools and bath houses as well. The Maintenance team replaced all the lights in the Billiards room with Flat Panel LED Lights. Saunas units and controls were replaced in each locker room. in the mens room and is currently being replaced in the women's.

## **Bike Safety Reminder**

Residents must use the bike racks available at every recreation area. Bikes are not permitted on pool decks as this is a serious health code violation. Bikes found abandoned or repeatedly left in unauthorized areas may be booted by Security or removed by Management.

# COOCVE Board of Directors Meeting — 9/16/25

All minutes are printed as submitted by the organization.

Macky called the meeting to order at 9:30 a.m.
In her President's Comments, Macky addressed the following:

- The attorney webinar to address the legal updates due to the passage of HB 913 will be held on 9-18-25. Thus far, there are 155 registrants;
- The "Ask the Lawyer" webinar will be held on 10-23-25. All questions must be submitted in advance for the attorney's review by 10-9-25. Like questions will be combined;
- The Presidents' Forum has been rescheduled from 9-23-25 until 9-30-25 because of Rosh Hashanah;
- SDP: we know that 21 of the 31 buildings that contacted COOCVE and stated that their boards had voted to pursue updating their documents have followed through with KBR. We are interested in hearing from the other 10 buildings. Is there anything COOCVE can do to assist you in bringing this to a conclusion?

Howard gave the Treasurer's Report;

• On 8-1-25, the opening balance in the Bank of

America Operating Account was \$91,821;

- There were no deposits into the account;
- Expenses in the month of August were \$3,480;
- The closing bank balance was, therefore, \$88,341 on 8-31-25.
- The 8-31-25 balance in the COOCVE emergency CD account was \$35, 835.

Howard informed the Board of Directors that Cen-Club has notified COOCVE that it has recently voted to reduce their funding support of COOCVE from the \$53,000 pledged to us in 2025 to \$35,000 in 2026, a reduction of 34%. No explanation was provided.

- COOCVE intends to continue to deliver the important programs planned for the community in 2026
- Informative and educational programs to help strengthen condo associations and boards with increasingly complex state and local statutes; Assist CVE owners in understanding their rights and their responsibilities as condo owners.
- In order to decrease expenses, COOCVE will no longer employ a temporary

administrative assistant. Rather, administrative functions will be assumed by the seven elected volunteers who comprise our Executive Board. Our COOCVE office will remain open for business on Wednesdays and Thursdays and will be staffed by an Executive Board member.

Joe Coppolla gave a report on the Election Committee;

- 3 positions are available for both Cenclub and Master Management with 7 available for COOCVE.
- ° COOCVE is splitting up the positions for the first time, with ½ for 1 year and ½ for 2 years to get it on a staggered basis.
- "Intent to Run" forms are available in paper form in the offices of Master Management, CenClub and COOCVE as well as online at coocve.com and will be printed in the Reporter. The completed form along with associated documents must be received by 11/6/25 at 3:00 p.m.
- "Ask the Candidate" is scheduled for 1/7/26

Eli gave the report for Master Management

• The wall on Hillsboro has been completed. Now the planting needs to be done.

• The front gatehouse is on schedule to be completed in November. They are working on putting stucco on the outside and finishing the inside.

There was no report this month from CenClub

Seacrest, Wright Management and East Coast: All 3 management companies basically said the same thing: they are all 3 busy scheduling budget and annual meetings.

The registration of Canadian autos was discussed at length. It was decided that the discussion would be tabled and addressed with the sheriff at the Master Management meeting next week.

Commissioner Daniel Shanetsky informed the Board of Directors of what had occurred at the meeting on 9-15-25:

- CGA has been replaced by CAP as the new permitting company. CGA did not do a good job in getting our permits issued or getting inspections completed in a timely manner.
- Deerfield Beach is still in negotiations with the BSO.

We may stay with Broward County or we may elect to join with another city. Both Crystal Lake and The Meadows have expressed interest.

Smoke detectors in the bedroom are the law. To assist with compliance, the Red Cross will be providing free smoke detectors and will be installing them free of charge. The sign-up sheet will be at the COOCVE office on 10-16-25. It will take about a month from sign-up until installation.

Emerson Poort talked about insurance. Neither he or any other insurance agent knows premium increases or decreases until November. He is hoping that Property Insurance rates go down this year.

• He said that new companies may enter FL but be careful. They have done it before and left after a year. American Coastal has been providing our Property Insurance for 15 years.

The next Board of Directors meeting is October 21st.
The meeting was adjourned at 11:00 a.m.



# What is **Elder Abuse?**

Each year hundreds of thousands of older persons are abused, neglected, and exploited. Many victims are people who are older, frail, and vulnerable and cannot help themselves and depend on others to meet their most basic needs. Abusers of older adults are both women and men, and may be family members, friends, or "trusted others."

In general, elder abuse is a term referring to any knowing, intentional, or negligent act by a caregiver or any other person that causes harm or a serious risk of harm to a vulnerable adult. Legislatures in all 50 states have passed some form of elder abuse prevention laws. Laws and definitions of terms vary considerably from one state to another, but broadly defined, abuse may be:

- Physical Abuse inflicting physical pain or injury on a senior, e.g. slapping, bruising, or restraining by physical or chemical means.
- Sexual Abuse non-consensual sexual contact of any kind.
- Neglect the failure by those responsible to provide food, shelter, health care, or protection for a vulnerable elder.
- Exploitation the illegal taking, misuse, or concealment of funds, property, or assets of a senior for someone else's benefit.
- Emotional Abuse inflicting mental pain, anguish, or distress on an elder person through verbal or nonverbal acts, e.g. humiliating, intimidating, or threatening.
- Abandonment desertion of a vulnerable elder by anyone who has assumed the responsibility for care or custody of that person.
- Self-neglect characterized as the failure of a person to perform essential, self-care tasks and that such failure threatens his/her own health or safety.

# What are the warning signs of elder abuse?

While one sign does not necessarily indicate abuse, some tell-tale signs that there could be a problem are:

- Bruises, pressure marks, broken bones, abrasions, and burns.
- Unexplained withdrawal from normal activities.
- Sudden changes in financial situations may be the result of exploitation.
- Bedsores, unattended medical needs, poor hygiene, and unusual weight loss are indicators of possible neglect.

Most importantly, be alert. The suffering is often in si**lence.** If you notice changes in a senior's personality or behavior, you should start to question what is going on.

Remember, it is not your role to verify that abuse is oc-curring, only to alert others of your suspicions.


