Fried Raises Trust Issues during CVE Event

During a visit to Century Village East last month, Democratic gubernatorial candidate Nikki Fried offered clear, if not couched criticisms of her Democratic primary opponent Charlie Christ.

Both Fried and Christ are running as Democrats in the upcoming primary race for

Florida governor. Fried is currently the Florida Commissioner of Agriculture, and the only Democrat to hold statewide office. The winner of the Democratic primary will face Republican incumbent governor Ron DeSantis.

During a visit to Le Club in the Village, Fried's comments

focused almost exclusively on drawing differences between herself and Governor DeSantis. But the only way she will run against Governor DeSantis is to win the Democratic gubernatorial primary. Her strongest opponent thus far in that race is former Florida Governor and current Florida

Congressman Charlie Christ.

When asked in front of an all-Democrat crowd about the strongest differences between herself and Christ, she alluded to Christ's switch from the Republican Party to the Democratic Party. Christ began his political career almost 30 years ago as a Republican.

In 2010, he left the Republican party to run for office as an independent. He later joined the Democrat party in 2012.

"There's every single difference between myself and Charlie," Fried said. "First and foremost, I became a



Dangerous Crossing

Dear Editor,
My wife and I
would like to comment on
the very dangerous pedestrian crossing on Military
Trail joining the two malls:
Century Plaza on the West
side and Latinos mall on the
East side, just south of the
Hillsboro Boulevard intersection.

There is a pedestrian crossing light there but motorists travelling north and intending to turn left, or west, on Hillsboro, just one block away, are generally unaware of the pedestrian crossing light because their eyes are focused on the left turning traffic situation at Hillsboro just one block away.

Traffic intending to go straight through or turn right at Hillsboro is always stopped by the overhead pedestrian light bar. This bar extends over the two right hand lanes but not over the left-hand turning lanes. Since there is no pedestrian crossing signal over their own lane, motorists planning a left-hand turn

can easily and erroneously assume that any right hand side traffic which is stopped is being held up by the Hillsboro light one block away. For traffic going north on Military, with the intention of turning left on Hillsboro, an extension of the existing pedestrian light system to cover all the traffic lanes at this point is badly needed.

Anyone willing to observe for a half hour or so at this crossing can readily see the dangerous situation that exists. My wife and I cross at this place regularly

and it is no exaggeration to say that we see motorists inadvertently running the light just about every second time we cross. They are not scofflaws; they are victims of an unintentionally badly designed crossing. The crossing itself is important to join the two malls together and should be retained because many elderly people use it. Fixing it to avoid deaths is possible and should be done immediately.

residents. Until the concrete is poured, I will continue to protest. Please be on the lookout for upcoming notifications regarding this project. Your voice is critical right now, and I need your help.

Now, lets' talk about new water rates in the city. We have not raised the water rate for over ten years. The cost of providing good-tasting and clean potable water has gone up, so it is time for a rate increase of about seven percent. For single-family homeowners, the increase will



be about \$4.00 per month (if using 40,000 gallons in that period). Those of us here in the Village are looking at an increase of about seven cents a month. So, please do not panic when you hear about this rate increase.

I have initiated a nonpartisan voter assistance program in the clubhouse every Friday from 9 AM to 1 PM. Please be sure to register to vote or, at the very least, check your voting status with the Supervisor of Elections. Any voting problems can be resolved on the spot. Please take advantage of this wonderful service that is being provided to us.

Finally, please remember,

as your commissioner, I am here to advise anyone with concerns about city-related business. If I cannot help you, I can at least point you in the right direction. On the first and third Monday of every month, I am available on the clubhouse's third floor. You do not need an appointment. Call me at 954-415-5658 or 954-870-0214. I will always call you back.

Market Reports

The Broward County Property Appraiser's Office gathers property sales information across the county on an ongoing basis. The BCPA Market Report, which is updated on the 16th of every month, reflects the prior month's sales data. These monthly reports provide a visual representation of the properties sold along with the median sale prices for residential properties. The top five cities with the most sales are also listed. The BCPA Market Report can be found at https://web.bcpa. net/bcpaclient/#/Report-Market-Sales.

Live Data Reports are also available on our website showing the current parcel



count, average just value and median just value of properties within Broward County. Website visitors can also download a year-to-year comparison of sales by selecting the specific month. Above is a sample of the market report available online.



Veterans with a Service-Connected Disability

Veterans with a service-connected disability rating of 10% – 99%, or their surviving spouse, are eligible to receive a \$5,000 exemption on their

homesteaded property's assessed value. Florida law also provides a full exemption for veterans with a 100% service-connected disability rating or the veteran's surviving spouse.

If your service-connected disability rating has increased to 100% since you initially filed for your Veteran's Exemption, please provide our office with a certificate indicating your 100% service-connected disability rating from the US Government or US Department of Veterans. You can email a copy of this certificate to exemptions@ bcpa.net. The deadline to file for all 2022 exemptions is September 19, 2022.

We expect this to be another very popular session, with lots of time allowed for questions. The recording will be posted on Coocye.com.

Hopefully, with fewer people around this summer, we can turn our attention to

WHO TO CONTACT IN AN EMERGENCY???

Does your Board have an emergency contact for every resident? Whom do you call if a resident is injured, hospitalized, in need of help, displaced during a hurricane, or if there is a problem with his/her unit and you can't reach the Owner? A Personal Data Sheet for each unit can help identify emergency contacts, the unit's condo sitter, the age of the residents (for the Census report), the summer address for snowbirds, etc.

BEING A SENIOR RESIDENTIAL COMMUNITY

CVE was created as a Senior Adult Residential Community.

Retaining that status necessitates the enforcement of age restrictions that prohibit children from becoming permanent residents in the condominium. We follow the Fair Housing Amendments Act of 1988 which prohibits discrimination based upon age unless occupancy is intended for and restricted to persons 62 of age or older (100%), or restricted to persons 55 of age or older (with at least 80% of the units having one person 55 or older.) U.S.C.3607 (b) (2) (c), F.S. 760.29 (4) (b) 3

DOCUMENTS & CENSUS

To maintain its status as "housing for older persons" (senior adult community), the Association must publish and adhere to policies and procedures that demonstrate an intent to provide housing for persons 55+. That means the Association's Documents and Rules and Lease Provisions must support those policies.

In addition, the Association must keep a "Census" of all residents (updated at least every 2 years) that verifies the age of the occupants. This list must be available in response to a familial status complaint by an applicant or a real estate firm.

The 80/20 rule is intended as a safety measure and is not intended to authorize the general sale or occupancy by a percentage of younger residents. If allows the 'under 55' occupant to stay in the unit. For example, if the sole 55+ occupant dies and a surviving spouse or heir remains in the unit, the surviving occupant would count in the 20%. Note that the '55+ or older occupant' may be on vacation, hospitalized or absent for a season without affecting the exempt status. That unit will still be counted in the 80% so long as the 55+ Owner returns on a periodic basis, is not renting the unit, and maintains legal and financial responsibility.

To routinely authorize younger Residents (mistakenly thinking there is a 20% allowance available) violates provisions of the documents and rules, and could make those rules unenforceable in the future, thus threatening the "senior adult community" status.



CORPORATE SEAL

The Association Secretary is the designated custodian of the Corporate Seal. The signature of the President will bind the Association Corporation, and the Secretary traditionally verifies the President's authority by also signing or attesting to the President's signature and placing the corporate seal on the appropriate document. When the Secretary is not available, another Board Member may be assigned the Seal.

Condo Sitters - It is important to hire a condo sitter when absent from the unit for extended periods. Condo sitters check the unit to make sure the air conditioner is working and that there are no water leaks. Condo sitters should also have a key to the Owner's car if it is left in the parking lot, in case the building needs to move it during the Owner's absence.

The Sitter's contact information should be clearly posted inside the unit, and the information should also be given to the Association Board.

"This Country: My Life in Politics and History"

By Chris Matthews, Simon and Schuster, 336 Pages, \$28.99



THIS COUNTRY My Life in Politics and History

Former political writer and TV host, Chris Matthews, probably best known for his "Hardball with Chris Matthews" daily MSNBC show, writes of his role on the political scene, beginning with his tenure as a member of the Peace Corps, moving through his days of door-knocking on Capitol Hill where he succeeded in landing his first job, a staffer to Utah Senator Frank Moss – a job that "opened my eyes to the game of big-league politics."

In the 1970s, Chris mounted a campaign for Congress as a Democratic maverick running against Philadelphia's old political machine. He didn't win the most votes, but his grit put him on the path to a top job in the White House. As a speechwriter for President Carter, Chris witnessed the triumphs and tragedies of that administration.

After Carter's defeat, Chris became chief of staff to legendary Speaker of the House, Tip O'Neill, a perch that gave him an on-the-job PhD in American politics during the Reagan years.


Chris then leapt to the other side of the political matrix as a columnist and reporter. He covered the falls of important people, critiqued openly, often harshly, the actions and characters of others. What

he didn't see was his own fall. He writes, "I've always believed in gender equality in the workplace. On Monday, March 2, 2020, I said I had not honored that standard in words when I made reference to a guest's appearance. It never occurred to me to deny that it happened or condone what I had said. The following Monday, I began my TV show by announcing that it would be my last. I recognize those kinds of comments were never okay, not then, and certainly not today. For making such comments in the past, I'm sorry."

Whether you liked Matthews or not, if he was forced to exit his show, you've got to admit he did it gracefully. And like a man.

"Hollywood Eden"

By Joel Selvin, 285 Pages, Anansi Books, 285 Pages \$XX.50



There was a time when California was a quiet corner of the country and Hollywood was a small town. The population of Los Angeles doubled in size during the Forties and added half again in the Fifties but was still a scrawling, scrawny collection of villages spread over five hundred square miles. Santa Monica's University High School served the wealth residents of Bel Air and Brentwood in west Los Angeles.

Everybody at Uni High knew they went to school with Nancy Sinatra. Her father was the number one entertainer in the business and gave her the first pink '57 Thunderbird made by Ford as a seventeenth birthday present. Nancy was one of the Hollywood celebrities, a group that included the Beach Boys, J & Dean, the Byrds and the Mamas and the Papas who came together in the epic spring of the 1960s to invent the myth of the California Paradise at the dawn of a new golden era when anything seemed possible.


But their own private struggles belied the paradise portrayed in their music. What began as a light-hearted frolic under sunny skies ended up crashing down to earth just a few short, but action-packed, years later, as one by one each met their destinies head on.

Nancy lived in a seven-bedroom Spanish mansion with a cobblestone courtyard and a swimming pool in Holmby Hills with her mother who had bought the house for a princely sum of \$250,000 after divorcing Frank when Nancy was ten years old. Nancy became a pop music superstar after releasing her first hit song, "These Boots Were Made for Walking."

"Hollywood Eden" is a fascinating rock 'n roll opera loaded with violence, deceit, intrigue, low comedy and high drama as it tells the story of a group of young artists and musicians who bumped heads, crashed cars, enjoyed fabulous fame and wealth and made international headlines. It also tells the story of far too many of them who, ultimately, flew too close to the sun.

"The Night Always Comes"

By Willy Vlautin, Harper, 208 Pages, \$26.99



Award-winning author Willy Vlautin explores the impact of trickle-down greed and the opportunities of gentrification on ordinary lives in this searching novel that captures the plight of a young Oregon

woman pushed to the edge as she fights to secure a future for herself and her family.

Barely thirty, Lynette is exhausted. Saddled with bad credit and juggling multiple jobs, some illegally, she's been diligently working to buy the house she lives in with her mother and her disabled brother, Kenny. Portland's housing prices nearly quadrupled over the past fifteen years and the owner is giving her a good deal should she decide to purchase the house. Lynette knows it's her last best chance to own her own home – and obtain the security she's never had.


While she has enough for the down payment, she needs her mother to cover the rest of the asking price. But a week before they're set to sign the papers, her mother gets cold feet and reneges on her promise, pushing Lynette to her limits to find the money she needs.

Set over two days and two nights, the novel follows Lynette's frantic search – an odyssey of hope and anguish that will bring her face-toface with greedy, rich men and ambitious hustlers, those benefitting from and those left behind by a city in the throes of a transformative boom.

One day she finds she is pregnant by her boyfriend, Jack. She finally tells him hoping he will do the right thing, or at least provide her some comfort. Instead, Jack tells her he doesn't want to discuss it. "I'm just going to say this to be clear. I'm leaving. I know we'll need to stay in contact about the baby. I'll give you money as much as I can each month until you have it. But then I think it's best if me and my family raise it and we'll fight with everything we have to make sure that happens."

This heart-wrenching novel raises the difficult questions we are often too afraid to ask ourselves when the unthinkable shatters the routine of a life taken for granted.

"The Saint Makers" By Joe Drape, Hatchette, 249 Pages, \$28.00



Subtitled "Inside the Catholic Church and How a War

Hero Inspired a Journey of Faith," this new book offers a front-row seat to the Catholic Church's saint-making machinery – which, in many ways, has changed little in two thousand years – and examines how, or if, faith and science can connect.

New York Times writer, Joe Drape, chronicles the unlikely alliance between country priest Father John Hotze and cosmopolitan canon lawyer Dr. Andrea Ambrosi, piece together the life of a long dead Korean War Medal of Honor winner and military chaplain and fashion it into a case for eternal divinity.

Along the way, Drape draws back the curtain on one of Catholicism's least understood processes, the making of a saint. And with a combination of journalistic skepticism and religious sensitivity, he confronts the question: Why do saints matter today?

And as the author writes, "The fast-tracked canonizations of Pope Paul and Mother Teresa and the induction of the once-miracle-shy Pope John show, public relations and good politics play important roles in the decisionmaking process. More Latin American saints are made so as to hold the line until more priests can be deployed to the once-Catholic stronghold that is now losing ground to the evangelicals.

Even Pope Francis has bent the rules of canonization by invoking 'equivalent canonization," allowing a pope to waive the normal rules in cases where the person has bee a Venerable for a long time and has a reputation for miraculous intercession. In other words, no documented miracles are needed. Further, certain church leaders now explain that the requirement to have miracles is a ecclesiastical law - not a divine one any longer.



Minutes of CVE CenClub Board of Directors Meeting -4/12/22

All minutes are printed as submitted by the organization.

'n attendance: Jay Baimel, LSusan Dove, Phyliss Meiner, Rita Pickar, Michael Rackman, and Stanley Spitzer; Executive Director, Mike Burdman, Norma Taylor, Property Manager (via zoom). Absent: Phil Raymond

Minutes:

Stanley Spitzer made a motion and seconded by Susan Dove, to waive the reading and approve the minutes of March as posted on the CenClub website and printed in the Reporter was made and carried unanimously.

President's Comments:

Rita Pickar

Rita wished everyone a Happy Easter. She stated that all is going smoothly and that the Board is working on next year's entertainment.

Treasurer's Report: Jay Baimel

At the beginning of March, the operating checking account balance was \$474,287. In March, \$1,003,357 was received, \$606,891 was disbursed and a net of \$30,882 was transferred to the reserve account for March 28, 2022, checking an operating account balance of \$839,871. Cash in the lockbox account (deposits in transit) totaled \$65,676 and two petty cash accounts totaled \$4,761. This provided CenClub with

total operating cash of \$910,308 with a reserve account at the end of March totaling \$4,616,573. The total aggregate cash at the end of March was \$5,526,881. Of the transfer to the reserve account, \$73,000 was transferred again for the funding of the insurance deductible. The reserve will continue at the same rate each month for the remainder of the new fiscal year ending September 2022, so the target budget of \$1,750.00 can be reached for this reserve item.

According to the capital needs plan, the reserve will be adjusted monthly as CenClub pays for the scheduled major projects and replaces them with new budgeted projects.

Significant budgeted and board-approved capital projects aggregating more than \$2.0 million are expected in 2022. These undertakings include a major pool modernization, miniature golf and putting green site, additional pickleball sites and reconstruction associated with our recently demolished golf building. CenClub's strong reserve position will complete the targeted plans in an advantageous and fiscally responsible manner. The quality and quantity of community and social amenities provided by CenClub and combined with the development of new and expanded facilities in 2022, will continue to underscore Cenclub's commitment to maintain and improve the quality of life in our community while stabilizing your cost at the lowest of the three coupons residents pay. Once again, we thank our owners for their enthusiastic support and appreciation of our efforts on their behalf.

Accounts receivable is \$242,066, up from \$238,971 an increase of \$3,095 from February 28, 2022. CenClub agreed with the auditors to establish an allowance for uncollectible accounts of about \$53,000 to estimate potential write-offs of bad debts. That allowance is less than ½ of 1% of the annual budgeted fees of \$10.7 million.

CenClub's accounts receivable staff has continued to focus successfully on collecting past due balances to protect the financial interests of the entire community and to hold all delinquent owners accountable.

Total assets at the end of March for CenClub Recreation Management Inc. were \$11,381,188 up from 10,769,888. Total liabilities were \$4,691,646, up from \$4,085,921. CenClub members equity (assets minus liabilities) is \$6,689,542, up from \$6,683,967.

Management Reports: Mike Burdman, Executive

Summer shows will be in the party room, and tickets are only \$6. Visit CenClub.com or our Staff Office for a full schedule and stop by the box office to purchase tickets. Food and drink are permitted in the party room for summer shows, and ice will be available. So bring your cups, paper goods, utensils, and ice buckets.

Dances have returned to the Clubhouse on Saturday nights. Remember, shorts are not allowed at the dances which start at 7:30 pm. These rules apply to ALL events in the party room. Guests are allowed to attend dances in the party room. The Clubhouse remains open for all residents and guests. As a reminder, residents must show and scan an ID card for access and guests must be accompanied by residents and registered with a security guard upon entry. As a note, guests must have a photo ID.

A resident must accompany children and guests at all satellite pools. Please keep food under the canopy and do not bring glass containers to the pool areas. Glass can be very dangerous if it gets into the pool as it becomes invisible to detect. Please use plastic or aluminum containers and dispose of all trash in the receptacles. 1 butt = 1 chair. Please be respectful of the restrooms; do not flush anything down that should not be flushed. Additional furniture has been ordered and will be distributed to those pools needing lounges and chairs. Please do not save a table for card or game playing. Please be respectful of the restrooms, and help keep our facilities clean.

Clubhouse/Recreation Updates and Improvements:

Replacement for office equipment has been ordered, including new irons for the sewing room, pickleball, and wax for the shuffleboard table. Residents can borrow this equipment and more from the staff office.

Residents will receive a phone call from a staff member to verify their Revalidation submissions. CenClub has revalidated over 11,500 residents, and plans for this project will continue until the end of July. If you have not completed the revalidation paperwork, please visit the Clubhouse offices or www.cenclub.com/id to submit your information online.

Construction has officially begun on our brand-new putting course. The putting course is similar to a miniature golf course and will be located on the east side of the Clubhouse and feature nine unique and challenging greens to practice your putting skills. In addition, the course is getting a nautical theme and will be available for play as soon as construction is complete. Please keep an eye on our announcements for more information concerning the putting course.

Another major project that just began is our building preservation and painting. Hartzel Painting and Construction started phase one of the project last week by fixing weatherdamaged stucco and concrete. Once complete, a refinish of the paint, and stamped brickwork will follow.

As a reminder, it's essential to be a part of our email list. Important updates, including information about the pandemic, events, classes, activities, and our monthly happenings, are sent out to every resident on our list. Remember, you can now join our mailing from the

comfort of your home by visiting www.cenclub.com. You can also sign up in person at the staff office.

Upcoming and In-Progress Projects:

- Oakridge pool deck with new pavers
- Repair of epoxy floors in 2 poolhouses (Westbury and Upminister)
- Diner windows and canopy over the outdoor seating area

General Maintenance:

The maintenance team completed 154 work orders in March. The team conducted a monthly survey for the Clubhouse and pools; lights were checked and replaced or ordered. The 10 HP motor that services the lake fountain was replaced. Installed two 12 x 12" junction boxes with outlets near the pickleball and the bus lot in preparation for camera installation. Ran a 350' CAT6 cable for networking and upgraded six light fixtures in the west hallway of the Clubhouse to LED panels to provide better, more efficient lighting. Painted picnic tables at the shuffleboard pavilion and replaced the Grantham men's bathroom water heater. Hallway lights on the 2nd & 3rd floors of the theater were replaced with LEDs and concrete around the restaurant was pressure washed. Replaced a toilet valve in the men's restroom at Berkshire pool and the fencing at the tennis courts damaged by winds was repaired and fastened. A shower wall at the Grantham women's bathroom was repaired.

Upcoming Maintenance Projects:

• Tennis and pickleball windscreens will be stored for the hurricane months and the fence padding at the Clubhouse pickleball courts.

Theater Maintenance and **Technical Update:**

Produced 11 shows in March. Serviced the hearing device system and replaced a power supply. The main speakers above the stage in the party room were serviced and repaired in preparation for the summer shows. Repaired the DVD input for the party room system and a video processor will be installed to improve the video quality and provide more input options. An HDMI input was installed on the wall in the GPA room for residents to plug their computers in for projector use easily. Inspected all theater equipment and serviced as needed. Mike thanked

Mike Prudente for helping and managing the theater throughout the entire season.

Pools:

The team completed 39 work orders in March. The pool team worked with Gulfstream automation to pull new wire and get the heat pumps at Durham, and Markham added to the automation system. The team pressure washed Upminster and Durham pool decks and walkways leading to the pools. They took four 6" valves on the sand filter for the Clubhouse pool and replaced three 4" valves on the return side going to and from the heat pumps. Inspected all phase monitors; no issues noted. The pool team checked all sump pumps, pool equipment and heaters; noted no problems. All pool safety equipment was inspected and cleared for use; noted no issues.

Upcoming Pool Projects:

- The pool team will be pulling new data wires at the satellite pools for the automation system controlling the heat pumps, replacing the old temperature sensors that provide accurate readings for the automation system and running new wires for these
- The pool team will be installing new pool rules signs at all the pools.
- Upminster pool resurfacing will begin on April 20, 2022.

Fitness Update: The CenClub Fitness Center Hours 7 a.m.-10 p.m. daily. Aquacise classes are at the Richmond pool. The average daily has been increasing steadily; 30 has been the average. Indoor pool hours are 7 a.m.-10 p.m daily. Reminder -Please don't swim alone; bring a buddy. Pickleball instruction @ the Tilford courts – Instruction is available Tuesdays, Wednesdays and Thursdays 8-8:45 a.m. beginner, 9-9:45 a.m. and 10-10:45 a.m. for intermediate/advanced - during the winter season; 35 has been the average. The summer schedule begins on May 2. The Fitness Center will be open from 7 a.m. to 8 p.m. daily during the summer months. There will be about 72 classes per week.

One hundred forty classes are taught per week. The topclass day was Monday, March 14, with 551 attendees. The top three classes for March were low impact aerobics w/ Shon - 63 attendees; aquacise w/Cleide- 61 attendees and low

Joint COOCVE Executive Committee and Council of Area Chairs Board Meeting -3/9/22 - Via Zoom

Macky Bachelor, 1st Vice President called the meeting to order at 9:30 a.m. and led the meeting with the Pledge of Allegiance and a moment of silence.

Carol welcomed all Area Chairs to the meeting and asked them to let COOCVE know if they held an area meeting and if there is anything they can share that was brought up which might be useful to all. In the coming months, COOCVE will be looking at ways to better support Area Chairs by offering training in support of the many roles that they play. Carol mentioned that COOCVE will be releasing another version of the Contractor's Survey; to do this, COOCVE will need updated information from buildings. Carol encouraged all Area Chairs to speak to their Presidents and BODs and ask them to send COOCVE any listings of contractors that they have used in the past and provide a rating of the experience they had with them so that the information can be shared with others who can benefit from their findings. Carol reminded Area Chairs that the form is available as a fill-in form on the COOCVE website under Forms.

Carol also touched upon the recent murder that took place in one of the buildings in CVE; this had a very chilling and traumatic effect on the building that experienced this. COOCVE reached out to the building to see how they can help them now and in the future with mental help support for the trauma and the grieving. COOCVE found a group in Connecticut that has a national response system with crisis teams all over the country. COOCVE was able to contact the local team in Broward who came out and met with several residents of the building in the last few days. COOCVE will make this information available on their website. Carol mentioned that after speaking with Captain Hofstein she learned that he has experiences in many areas including violence, trauma, belligerent and troublesome residents,

threats and acts of violence or destruction. Captain Hofstein is prepared to speak to CVE residents at the next BODs meeting about what they can do in these situations. If there is enough interest in the Village, COOCVE would like to have Jennifer Cunha host a seminar on the various legal actions that BODs can take with regard to residents having difficult behavior. Carol then asked all in attendance at today's meeting to state in the chat if they are interested.

Macky announced that COOCVE is hosting a **President's Forum** on Tuesday, March 22 at 1 p.m. Please submit any agenda items to Macky Bachelor at COOCVE@coocve.com.

A **Secretary's Forum** is being planned for early April. Information such as minutes, Robert's Rules of Order and association records will be discussed to assist secretaries in their role. More information will be coming shortly.

Carol mentioned about four-fifths of the Officer and Director forms have been submitted to COOCVE. There are many new Presidents and COOCVE Directors, so please submit the remaining forms as soon as you can. Please encourage Directors to list their local phone number, not their Canadian number.

COOCVE has received several inquiries about buildings' and guests' occupancy policies. COOCVE is learning that most buildings have policies for guests that are unclear. The policies are clear about children, i.e., no longer than 30 days, but it is not clear on the adult guest policies and may not be as enforceable as it should be. Macky suggests to those that are amending their documents to look at the guest policy (typically in section 9.1) and amend that as well. Many inquiries are also being received from mortgage companies and Macky suggested that everyone review their documents to see what is required when someone applies to be a resident, i.e. the amount required to put down.

Treasurer's Report – Rich Wiener

The opening balance for

February 2022 was \$69,259.07. Expenses for February were \$233.76; The balance as of March 1 was \$69,025.31. YTD expenses were \$18,661.08, YTD income is zero. COOCVE has an Optimum Bank CD in the amount of \$52,000 that is due in June.

President's Report - Carol Freedman

Carol reminded everyone to take a look at the most recent 2-page spread in the *Reporter*. There is a lot of useful information on many of the issues that Area Chairs are currently dealing with.

Carol also mentioned that many buildings are inquiring with COOCVE about root intrusion as they are now experiencing this issue in their showers and toilets and have concerns about where the responsibility lies for fixing the problem. This is an issue that many buildings will face as they continue to age. Carol said COOCVE is investigating this and asked that Area Chairs who are facing this issue, mention it in their report. Rita replied that this has been ongoing for years as it is from the ficus trees that are growing in front of the buildings as these roots seek water and head towards the shower and toilets. Rita mentioned that it is the responsibility of the building and about six years ago, many buildings removed the ficus trees and planted trees that were less intrusive. Carol pointed out that the problem may occur for ficus and other bushes used as hedges near the building.

Carol then turned the meeting over to Harriet Drandoff, Chairperson of the Council of Area Chairs. Harriet reminded everyone that only Area Chairs can speak first; all others will be able to speak during the open mic part of the agenda. She also stated she received two phone calls this morning asking for various CVE phone numbers. She reminded these individuals and is mentioning on this call that the Reporter has a listing of important numbers. She asked Area Chairs to remind their residents to pick up a copy of the Reporter as it has a pullout for CenClub, 2-page

spread for COOCVE as well as other useful information. Macky also mentioned that on the COOCVE website there is a listing of handy phone numbers with hours of operation. Carol shared that COOCVE has agreed to make available to Area Chairs the emails and phone numbers of Presidents in their areas and COOCVE is in the process of contacting all Presidents for permission to release their email addresses to Area Chairs.

Master Management -Eli Okun

Eli mentioned that in the last month, a resident was struck and killed by a car on Military Trail and an Upminister resident was hit inside CVE on Century Blvd. These two accidents had one thing in common; the pedestrians were not in the crosswalk.

MM is asking all residents not to feed the ducks; it is not healthy for them and this invites them to come onto the catwalks and sidewalks. Eli also urged drivers to be careful as several ducks have been killed on the road in the last month.

The **east bus has expanded the hours** on Sundays beginning at 9 a.m and will continue throughout the season.

Eli asked residents not to use drinking water or hose water when washing their cars in the Village. This is portable water which is connected to CVE's system, which we pay for. Only portable car washers, who bring in their own water, can wash your car; this is the only means of washing cars inside CVE.

MM has adopted a caring beyond the gates campaign by cleaning up Hillsboro Blvd. and Military Trail from papers and debris alongside the roadway. Call Master Management for details to volunteer.

Work on the right turn lane on Military Trail will begin the week of April 25. A notice will be sent out informing residents since there is a possibility of the east gate being closed during the paving process.

The next **Master Management Board** meeting will be

held via zoom on March 10 at 9:30 a.m.

Harriet mentioned that residents walking in the Village at night wear light clothing as it is difficult to see walkers late at night with dark clothes. She also suggested to MM and Bernie to offer reflective bands to walkers so that they can be seen late at night.

CenClub – Mike Burdman - Executive Director

Mike thanked everyone who attended yesterday's CenClub meeting; it will be on channel 98 shortly as well as on the CenClub website. The CenClub BODs removed the mask requirement while residents are in the common areas of the Clubhouse except during theater shows. Tickets for the March shows were sold under the mask mandate guidelines and the Board felt it would not be fair to those who purchased tickets under those guidelines to have it lifted. Please continue to wear your mask to shows in the theater for the remainder of the season.

Revalidation of CenClub IDs is going great. Blue IDs are still valid and will be until the revalidation process is complete. Residents are receiving phone calls from our staff members to verify their Revalidation submissions. CenClub has revalidated over 9,200 residents, and plans for this project will continue until the end of July. If you have not completed the revalidation paperwork, please visit the Clubhouse offices, or www.cenclub.com/ id to submit your information online. After a 2-month relief transition period in connection with the ID revalidation project, CenClub will again be charging late fees beginning in March against pastdue owners.

CVE is always looking for instructors for new classes. If you have a hobby and would like to teach a class to your fellow residents, stop by the Staff Office to see how you can become an instructor. Haley Comerford (Cum-erferd) is our new Assistant Director for Events and Reservations. Join us in welcoming her to the CenClub family.

President Eli Okun called to order the regular meeting of the elected volunteer Board of Directors of CVE Master Management at 9:30 a.m.

Remote – Gene Goldman Following the Pledge of Allegiance, a moment of silence was held for those who gave their lives in service to preserve our democracy and for the victims of the war in Ukraine.

Meeting Minutes: (9:31:58 a.m.)

The Board unanimously approved the Minutes of the February 17, 2022, MM Board Meeting following a spelling correction and the March 3, 2022, Executive Session Meeting as presented.

President's Report – Eli Okun: (9:33:36 a.m.)

1) Pedestrian Safety Update –

Eli informed two Residents were struck by cars last month, one occurred in front of Upminster and one killed outside the Village on Military Trail, both individuals were not in crosswalks. MM cares about the well-being of the Residents and asked Residents to follow the rules of the road and look both ways before crossing the street.

2) Transportation Update – (9:34:16 a.m.)

By request, MM has extended the East Bus service hours on Sundays beginning at 9:00 AM. It was previously 10:30 a.m. This will continue through the end of the season. MM looked forward to the arrival of the first of seven new state-of-the art buses within the next two weeks; the remainder to follow shortly thereafter. The familiar looking buses will be equipped with many new features such as front-kneeling suspension, so the bottom step will be approximately seven inches from the ground when the door is opened, a 1,000 lb. rear-lift capacity, anti-viral package with a special filtration system, anti-microbial seats; grabs bars on each side of the door; and up-to-date LED lighting for a very enjoyable experience. Eli thanked Michael for his hard work and tremendous amount of time enhancing the bus services in

the Community.

3) Financial Report -

3) Financial Report – **(9:35:49 a.m.)**

Eli informed today's meeting was held a week early to observe the Jewish holiday and the Treasurer will report the past two months' reports at the next open Board meeting.

Executive Director's Report – Vallen Smikle: (9:36:42 a.m.)

Val thanked everyone for attending and informed there was audio interference with the Zoom platform and directed Residents to tune in to watch the video of the meeting posted on Saturday morning.

1) New Master Management Connect App –

Val expressed the impor-

tance of transparency with the community as to what we are working on. Val then wanted to start off with our app, "Master Management Connect" and welcomed Customer Service Representative, Angelica Saavedra, to explain the new app that's taken off like wildfire. Angelica demonstrated the app by first instructing to download the app from the Apple Store by typing in "Master Management Connect" and click on the icon to download. With the app you have a number of options to include calling MM directly, submitting Work Orders, calling in your guests through the automated system, connect directly with Security personnel, view bus schedules, view the latest MM news, past and current issues of the Insider which is updated the first week of every month and contains the latest community information, submit coupon payments, and watch past meetings and current meeting. Angelica highly recommended that Residents register in the app to create a profile to receive updates/ notifications for work-orders placed. A QR code is posted on the buses and in the MM office; click on the image to download the app. Angelica offered her assistance by phone or stopping by the office for assistance in accessing the app. Val stated the app is continuing to evolve and hoped to launch the new bus locator app with the assistance of Resident, Professor Donald Grossman, and the IT team working to upgrade the tracking software. Val said many Residents have called in and offered their expertise with various matters. The

Gatehouse app will be avail-

able soon, allowing Residents to authorize guest access by sending them a scannable boarding pass that the guards can scan for instant access through the Gates, and hoped to implement the new technology once all the Guardhouses are completed. (Review the video at Time Stamp for detailed app demonstration and additional details.)

2) Century Village East Website – **(9:45:39 a.m.)**

Val described the primary website, centuryvillageeast.com, was a great tool to connect the Community organizations with links to keepingcvebeautiful.com for project news updates, cenclub.com for recreational topics, and COOCVE for educational information, a visitors section, resources, documents, and a welcome home tab for Residents featuring latest news, transportation, FDOT 10th Street connector, vendor registration, governance, Master Management meeting videos, community rules, environmental, as well as a tab to contact MM directly. Val said Residents can fill out a Vendor Registration form to source trusted, reputable vendor information is sent directly to Security and customer service to keep track and reach out to the companies. For example, a Resident's driveway was blocked by a vendor pallet left in their parking space and was unable to locate the owner, so this is a great source to share information between the buildings. The list will also be shared with Carol Freedman, President of COOCVE.

3) Irrigation Work Orders – **(9:48:00 a.m.)**

Val reported Robert and Denis have assisted the maintenance specialist and have called in vendor, TCI, to assist in catching up on the numerous irrigation work orders as quickly as possible. Val displayed the Master Management Connect app depicting an irrigation work-order locator map where the blue dots reflect closed work orders and the orange dots show open work orders.

4) Project Updates – **(9:49:00 a.m.)**

Val said the keepingcvebeautiful.com site is updated weekly and contains past, present, and future projects content. Work on the East turn lane will begin the week of April 25 and should last 2 weeks. The gate will periodi-

depending on the MOT plan we receive from the City, for two weeks during construction for everyone's safety as well as the safety of the work crew and will be accessible for emergency personnel only; usually keeping the outbound lane open for inbound traffic for emergency vehicles, as we do not want to impede them in any way. The final two lake fountains will be installed by the end of the year. The vendors have been working tirelessly to complete the Lighting Project to get new lighting to where it needs to be within the Village, having installed 48 new poles out of 150. Val hoped to have an FPL update next month advising when the 34 light fixtures on backorder will be available and when the transformer that was supposed to be replaced at Grantham F is ready. Currently the area at Grantham F is roped off for safety and FPL has been advised of this. Following the completion of phase one of the perimeter wall at Military Trail, we will be moving on to phase two this year and hope to submit for permit next month and will be adding a decorative wall along Hillsboro Boulevard and plantings along the fence line in the Westbury area. Robert Streather, Director of Operations, is working with the City Department of Parks and Recreation in a proactive attempt to clean up the exterior of Century Village and coordinate schedules to clean up the debris outside the Village perimeters; SW 10th Street, Powerline Road, Military Trail, and Hillsboro Boulevard. The 2022 paving project will begin in June at Marham and Lyndhurst. Val was pleased everyone in the area signed up for the project. The originally installed thermal plastic in 2016 will possibly be refreshed. Future projects include Central Park, bus shelters, the main Gate, multi-path walkways--the first set scheduled for Lyndhurst. The Tilford courts will be refreshed this summer, and the utility wraps will be completed by the end of the year in the fourth quarter.

Christopher advised Resident ID cards do not expire. Tenants have a oneyear expiration date that coincides with the barcode vehicle transponder. If their ID card or barcode transponder does not work, they have to get those renewed at Security. There are other types of badges throughout CVE with expiration dates that vary for vendors/services, depending on what they will be doing and the HOA has authorized them to be used, and they expire, as well, and these types of badges do not come with barcodes.

b. February BSO Report – Christopher added to the President's report on safety and recommended Residents wear bright colors and/or reflective material when out walking at night.

He said BSO was doing great job and gave the following report for the last month: 10 citations issued for failing to stop at a stop sign; 4 citations for speeding; 1 citation for operating a vehicle without insurance; 2 citations for failure to display registration on vehicle; 2 citations for failure to yield to emergency vehicles by law; 3 citations for not carrying driver's license. For safety, commercial vehicles were also checked and 4 citations were issued for no proof of insurance. One pedestrian was cited for not using the crosswalk. There were 2 DUIs -- 1 citation for open container in vehicle and 1 citation for fraudulent loaning of a driver's license. Val clarified that BSO issues citations and not MM.

Per member inquiry these citations were issued during the month of February. Christopher commented that we will always be one month behind on reporting this.

c. Customer Service -Christopher informed Allied Universal continually trains all the guards throughout the Village, implementing competitive white glove training. This information will be posted on the COOCVE website under Resources https://coocve.com/ mental-health-resources and published in the Reporter. Carol also contacted Chief Hofstein and he shared some experiences that he has had over the years with residents when there has been trauma within CVE. Carol then asked him to share the information he found helpful with the Directors. Chief Hofstein thanked Carol for preparing the list of resources. He deemed the resources very reputable and thorough in what they do.

The Chief mentioned when there are critical instances in the Village or the Community, BSO has in-house resources for victims and those involved. The Chief spoke about troubled neighbor/tenant disputes. He also explained what public safety (police and fire rescue) is and is not capable of doing. The Chief reminded residents that there is no one cure-all for any situation. There is rarely a simple singular solution when dealing with troubled homeowners. The Chief also spoke about the options buildings have when dealing with difficult residents. He stated that the board should make a collective effort to find solutions. Law enforcement will get involved if a person creates a disturbance or criminally harasses someone. When situations do not reach the law enforcement level, it is vital to get the appropriate resources available. The Chief spoke about one of the resources, Henderson Behavioral Health - Mobile Crisis Team. This vital law enforcement partner should also be an integral partner of CVE. The Chief mentioned that Henderson recently came to the Village and was stopped at the gate. The Chief spoke about instances within CVE and Henderson's willingness to partner to assist the residents. He urged Security that anytime

Henderson comes to the gate

and is properly credentialed to let them in immediately. The non-emergency number is 954-764-HELP. COOCVE is exploring having Jennifer Cuhna, Esq. conduct a presentation to CVE on the types of actions that BODs can legally take.

Master Management –

Eli Okun, Board President Eli mentioned that he would speak to Security about Henderson Behavioral Health when entering CVE.

Eli mentioned a section for vendor registration on the MM website. All residents who hire vendors to work at Century Village East should register on this site for security purposes. First, residents input the name of the vendor, date of service, end of services, time of service, the residents' name, phone and address, and the vendor's name and phone number. Then, the form is sent to security, COOCVE and customer service.

Eli mentioned that a resident was struck and killed last month by a car on Military Trail and an Upminister resident was hit inside CVE on Century Blvd. These two accidents had one thing in common- the pedestrians were not in the crosswalk.

MM is urging residents not to feed the ducks in CVE. It is not healthy for them. Bread and similar items have no nutritional value for ducks. Feeding ducks encourages them to use CVE as their bathroom, leaving droppings on patios, sidewalks and porches. Please do not intentionally try and hit the ducks with your car.

Washing your car with drinking or hose water in the Village is prohibited. Only car washers that bring their water into the Village are allowed.

MM has adopted a **caring beyond the gates campaign** by cleaning up Hillsboro Blvd. and Military Trail from papers and debris alongside the roadway.

Installation on the right turn lane from Military Trail into the East gate will begin the week of April 25. MM will send a notice to residents on the distribution list. There is a possibility that the East gate will be closed during construction for a day or two; MM will inform the community of the closure.

An Area Chair asked Eli if there was a start date for the **outdoor playground**. Eli responded possibly in the next few months.

CenClub – Mike Burdman – Executive Director

Mike thanked everyone who attended the March CenClub meeting; it will be on channel 98 shortly and on the CenClub website. The next meeting will be on April 12.

The CenClub BODs removed the mask requirement while residents are in the common areas of the Clubhouse except during theater shows. March show tickets were sold under the mask mandate guidelines and the Board felt it would not be fair to those who purchased tickets under those guidelines to have it lifted. Therefore, please continue to wear your mask to shows in the theater for the remainder of the season. Residents only and tickets are available both online and in person. The schedule is posted online at www.cenclub.com. Shorts are not permitted in the theater.

Dances are in the Clubhouse on Saturday nights; they begin at 7:30 p.m. Guests are permitted and masks are not required.

Revalidation has been ongoing for the last six months. Blue IDs are still valid until the revalidation process is complete. Any residents who have not received their ID can come to the Clubhouse/3rd floor and get them in that day or schedule an appointment for the next day. The staff is calling residents who have not completed the revalidation paperwork. After a 2-month relief transition period in connection with the ID revalidation project, Cen-Club will again be charging late fees beginning in March against past-due owners. Please contact the staff office at 954-428-6892 if you have any questions.

Patty and Jose are performing tomorrow, March 16. Tickets can be purchased online or at the box office; the cost is \$15.

Mike mentioned that the **Richmond pool** is to be replaced due to issues with the structure. However, a date has not been secured as they are waiting on drawings and surveys.






